## TERMS & CONDITIONS: -

- i. Sealed tenders may be submitted to undersigned before the closing date and time, which will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at Gilgit-Baltistan, Chief Court Gilgit.
- ii. Contractors/Suppliers may offer only that category of tender in which he may have complete setup Own Shop/Store/Work Shop with all documentary evidence at Gilgit.
- iii. The Contractor/ Supplier must be sole proprietor having his own complete setup (Shop, Workshop, technical experts/staff) containing adequate supplies in Gilgit Town as well as Islamabad/Rawalpindi, duly supported by an agreement with the agent/authorised dealer at Islamabad/Rawalpindi on Affidavit worth Rs. 100/-.
- iv. The bid security/call deposit (refundable) in shape of bank draft by a schedule bank in the name of PAO/Registrar G.B Chief Court may be attached with the (Technical Documents) bidding/tender documents. Tender without call deposit from a schedule bank will not be entertained.
- v. Separate envelopes containing Technical and Financial proposal must be submitted before the closing date & time and only those bidders will be qualified for financial bidding who fulfils the technical terms and conditions.
- vi. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
- vii. The rates of items if not enlisted in the "Prescribed Form" will be determined in accordance with the prevalent retail price in the open market at the time of supply.
- viii. Firms quoting inappropriate rates as compared to market rates which shall not be considered.
- ix. All kind of Taxes applicable (if any) will be inclusive in the bid price and borne by the firms/dealers/suppliers/contractors.
- x. Conditional, ambiguous and incomplete tenders will not be accepted.
- xi. Bank statement for One year, five year's work experience in relevant field, firm registration certificate, CNIC of the owner, Letter Pad of Firm with address, Vendor Number & Telephone Number must be attached with technical bidding documents duly attested.
- xii. The PAO/Registrar reserves the right to accept or reject any one or all the tenders as per relevant instructions/guidelines of PPRA.
- xiii. Tender documents fec as per category wise mentioned in the GB Finance Act 2022 may be deposited into Government treasury through challan and copy thereof be attached with the tender.
